2023/24 COMMUNITY LIVING STANDARDS

Welcome to Owen Sound Student Residence.

As a residence here you are required to act in a responsible and respectable manner.

Non compliance to any of these rules can result in Notice of Termination.

Here are a list of rules and regulations to which you must adhere so that everyone has a safe and comfortable living environment.

- 1. Overnight guests-Only the person named on the lease may occupy the room.

 No overnight guests are permitted without written consent from the landlord.
- 2. Cleanliness-Students are to clean and tidy up after yourselves in the shared living spaces (includes <u>bathrooms</u>, <u>kitchen</u>, <u>laundry</u> and <u>common areas</u>) as well as your individual unit. Students may be charged to have resident personnel clean a space if it is judged to be unsanitary/unsatisfactory after an inspection of resident personnel. Weekly cleaning staff will do a thorough cleaning of all areas of the building except individual units.
- 3. Smoking-All areas in the building are non-smoking. We require that students do not smoke within nine (9) metres of the building.
- **4. Underage drinking-**Students must abide by all Federal and Provincial laws. The legal drinking age is 19 years of age.
- Alcohol consumption-Students of legal drinking age may consume alcohol in their assigned rooms <u>only.</u> <u>Drinking in any other area of the Student Residence is</u> strictly FORBIDDEN.
- **6. Beer bottles**-Bottles are considered a hazard due to broken glass and are not allowed on the premises. This also includes alcoholic "coolers".
- 7. Illegal drugs-Students are prohibited from possessing and/or <u>using any illegal</u> drug substance in residence.
- **8. Door propping-**Propping doors that lead into the building compromises safety and security of the community. Any attempt to prop doors is not permitted.
- **9. Physically active games-**Students are not permitted to participate in potentially destructive activities that may cause personal injuries and/or property damage.
- **10. Throwing materials-**Throwing, dropping, hanging or ejection materials from or at the residence building, windows, and hallways or down stairwells in prohibited.
- **11. Appliances**-Electrical or other cooking appliances, including but not limited to toasters, toaster ovens, and hot plates are permitted only in the kitchen area.
- **12. Parking Lot**-The parking is to be used by the student residence, guests, store staff and delivery vehicles only. Driving at a reduced speed in the parking is required for everyone's safety.
- 13. Quiet hours-To provide students a suitable environment to pursue academic endeavors the following quiet hours are observed in residence:
 Sunday to Thursday 11:00 p.m. to 8:00 a.m.
 Friday and Saturday evenings 1:00 a.m. to 8:00 a.m.
